#### 8. Presentations

Celebrating God's Gift of Life and the Wonder of Life in our Community

# 1) Draft 2009-2010 Audited Financial Statements

Associate Director of Education (Business & Finance), Peter Derochie and Debbie Trickey of Hehn Trickey Professional Corporation presented a walk through of the audited financial statements. The report with a recommendation was considered under Action Items.

# 2) Update on Programme & Services Initiatives

Brian Beal, Executive Superintendent of Programme and Services presented a document to trustees. He walked through the first part of the System Initiatives Mid-year Update document and will address two further sections at future board presentations.

Topics covered at this meeting included: catholic values resources, developing student leaders, connecting Catholicity and curriculum, Fully Alive – grades four and five, grade 11 religion, religion and assessment, board improvement planning, school effectiveness framework, schools in the middle, student work study teachers and elementary initiatives.

# 3) Early Learning Kindergarten Program – Extended Day Fee

Peter Derochie, Associate Director of Education (Business & Finance) presented information regarding the development of the extended day fee calculations. Under



proposed new legislation, the board would be able to engage third party operators to run the early learning program at our mandated sites, under specified conditions. It is expected a process will be underway in February in those school communities that will be offering the early learning program, to gather data that will assist in determining extended day fees. Next steps include: development of fee calculation scenarios tied to the schools and programs potentially being offered; collecting information to share appropriately; designing a data collection process; developing a communication plan. The Board will be kept up to date on developments.

## 4) Trustee Orientation

Director of Education, Michael O'Keefe provided a brief outline of anonymous correspondence, policy resolution governance, complaint protocol, conflict of interest, and consensus decision making. It was felt that these were relevant issues that would be discussed at the OCSTA orientation sessions happening later in the week.

  - iii) make recommendations to the Board regarding next steps in the process.
