1) Summer Plant Projects

Glenn Clarke, Controller of Plant, provided a power point presentation of the various summer projects undertaken this summer, including: completion of the new St. Paul's replacement school in Alliston; the addition and renovations to Father F. X. O'Reilly School in Tottenham; addition and renovations to St. Joan of Arc in Barrie; addition and renovations to St. Peter's in Barrie; demolition of St. Bernard's in Orillia; set up of the former David Church School site to house St. Bernard's students until the replacement school is completed; work began on the design for Monsignor Lee replacement school. Energy efficiency upgrades and projects were completed at several schools including: new roofs at three schools; installation of wind turbines at five of the Board's schools, and T5 lighting installations at various schools.

1) Swim to Survive

Due to the increase in drowning deaths in the province, including two persons in the Huntsville area recently, it was suggested that the Board consider offering the *Swim to Survive* program to grade three students in areas where there is access to a public swimming pool. The program is run by the Life Saving Society of Canada and there is grant funds available. This matter was referred to staff to conduct research, investigate the feasibility, and report back to the Board.
