1) Report 8.1) 09-2010: St. Peter's Catholic Secondary School –Tender Award

of \$4,381,600 subject to municipal approvals.

# 3) Report 8.3) 09-2010: Father F. X. O'Reilly School – Tender Award

Recommendation: That the Board authorize staff to award the construction of

the addition and renovations to Father F.X. O'Reilly Catholic School subject to Ministry approvals, Municipal approvals and a recommended tender result within the allocated Ministry and Educational Development Charges

Funding.

Consensus of the Board of Trustees was not obtained for approval of the Recommendation.

## Recommendation BD.POL 04-2010:

That Board approve that Policy EP-01: Admission to Elementary Schools be revised so that section (d) reads:

"(d) If the child is a sibling of a student who is already in attendance in an elementary school of the Simcoe Muskoka Catholic District School Board then the sibling, shall also be admitted to the same school, provided the sibling lives in the same household."

Consensus of the Board of Trustees was not obtained for approval of the Recommendation.

Board Procedural Bylaw 9:08, indicates that when consensus is not obtained on a recommendation, that the Chair call for a mover and seconder for the motion. Trustee Connie Positano moved the motion but there was no seconder. The Chair advised that the policy would return to Board Policy Review Committee for further study.

# 1) Report 9.1) 09-2010: Georgian West Essa Base Borden Pupil Accommodation Review Staff Report

The report provided by Glenn Clarke, Controller of Plant, addressed responses by staff to the eight items raised by the delegations that presented at a special board meeting on May 17, 2010, which were: uphold faith of Clearview Township; the history of Our



Lady of the Assumption School; the unique situation of families on Base Borden; military parent perspective; transportation to Prince of Peace School; schools located on Canadian Forces bases across Canada; advantages of a small school with a student perspective; and Prince of Peace healthy lifestyle opportunities and relationship with St. Joseph's Chapel.

On June 23<sup>rd</sup>, staff will bring a final report with recommendations to the Board.

Trustee Rick Maloney expressed thanks and gratitude to St Peter the Apostle Catholic School, in Parry Sound, for the open and positive discussion held on May 25<sup>th</sup>, about the transition of becoming part of Simcoe Muskoka Catholic District School Board. He noted that while 90% are supportive of the transition, he is confident that all stakeholders in Parry Sound are willing to continue the transition in a cooperative and positive way.

Student Trustee, Jacob Brodka reported on his attendance at the Ontario Student Trustees' Association (OSTA) annual general meeting in Toronto. Jacob noted that financial literacy was the focus this year. He chaired the Incorporation Committee and researched and presented a report to the membership on incorporating the Association. It is expected that over the next few months the incorporation process will be completed. Jacob also announced that Student-elect Trustee Sergio Morales was elected Catholic Vice Chair of OSTA and he presented Sergio with a congratulatory gift.

Student-elect Trustee, Sergio Morales reported on his attendance at the Ontario Student Trustees' Association (OSTA) annual general meeting in Toronto. He advised that Student Trustee Jacob Brodka served on the OSTA executive as Director of Operations this past year and that Jacob worked on a Student Trustee Handbook that was published for student trustees across the province, as well, he wrote several articles for *Our Voice*, a student magazine. Sergio announced that Jacob Brodka has been elected Student Council President at St. Joan of Arc Catholic High School for the 2010-2011 school year.
